## MARTIN H. STECKEL

It is with great sadness that we announce the death, on February 4, 2023, of Senior Principal Martin H. ("Marty") Steckel following a brief illness. Please join us in expressing our condolences to his loving family and many, many friends.

Though born in Chicago and raised in New York, Marty was southern on his mother's side, with roots in Eatonton, Georgia. After graduating from high school in Bloomfield, New York, he attended Duke University where he tried out for the basketball team (unsuccessfully) and met his future wife Karen (with much greater success). He served in the U.S. Marine Corps Reserve and later received his bachelor's and law degrees from the University of Georgia, where he also served as a resident monitor in the football players' dormitory.
